CONSIGNMENT TERMS _____ (initial)

- Items will be accepted for a 60-day consignment period, starting from the day they are placed on the sales floor.
- Reclaimed Interiors will establish and set the pricing on all consigned items. We will always strive to secure the best possible price for your item based on manufacturer, quality, condition and marketability of the item.
- Inventory will be reduced in price 20% after 30 days. After 60 days if the item has not sold, the seller can pick up or have us donate. Sales and promotions are at the discretion of Reclaimed Interiors. **Reclaimed Interiors reserves the right to accept any reasonable offer regardless of the markdown schedule.**
- If items are picked up prior to the end of the consignment period, there will be a early pick-up fee of 20% of the starting price that is payable prior to the items being retrieved.
- **All consigned items must be clean, in displayable condition and ready for resale.** Reclaimed Interiors will charge a fee up to \$25 /each if items require additional cleaning, repair or assembly. The cost of this work will be deducted from consignor's portion of the proceeds from the sale. If an item requires fresh batteries to be operational, a charge of \$1/battery will be deducted from consignors account.
- All items consigned with Reclaimed Interiors remain the property of the consignor. Reclaimed Interiors will make all reasonable efforts to keep consigned items clean and safe from damage. Reclaimed Interiors is not responsible for LOSS or DAMAGE to consigned items due to fire, water, theft, or other casualty. Please ensure that all items are covered under your homeowner's policy or such other insurance as you deem appropriate.

COMMISSION _____ (initial)

- I understand my share is 50% of the final selling price for items sold within the 60-day consignment period.
- There will be a small fee added to each item depending upon its price. This covers marketing and credit/debit card processing fees. This fee is paid by the buyer, not the consignor. The consignor's payout will be based on the final selling price prior to the handling fee.

- **If you wish to retrieve your unsold items, you must do so within 5 days after the end of the consignment period. Please mark your calendar and monitor your online account. Reclaimed Interiors does not call to notify you of Sold / Unsold items.** Unless otherwise specified, items left in the store 5 days after the consignment period ends will become store inventory. Items will be donated to a charitable organization or liquidated at the discretion of Reclaimed Interiors.

PAYMENTS _____ (initial)

- For your convenience, we have a "Consignor Login" page on our website which enables you to track the status of your items and see available funds. Please use this to manage your online account. You can see the status of your consigned items, as well as your account balance.
- We do not automatically mail checks. Payouts of \$25 or greater are available for pickup at Reclaimed Interiors anytime, or can be used for store credit. (Sorry no cash settlements). If you prefer to have a check mailed to you, there is a \$1.00 mailing fee.
- **Consignment proceeds not requested to be issued by check after 12 months will convert to store credit ONLY.**
